Foreign investments are all property, financial, and intellectual assets mobilized by foreign investors for the purpose of obtaining a high level of income and efficiency in the economy of another country, entrepreneurship and other activities not prohibited by law. Foreign investment is a source of external financing, unlike domestic investment . They are attracted to the national economy from abroad, encouraging their arrival. But not all forms of attracting foreign capital can be an external source of financing. This applies primarily to foreign loans and debts that require repayment with interest payments. Because foreign loans and debts of international financial institutions require repayment of fixed interest along with the principal debt after a certain period of time. There are specific differences between foreign investments and foreign loans. In this regard, the scope of risks of foreign investments and the scope of risks of foreign loans differ.

" On Foreign Investments", foreign investors in the Republic of Uzbekistan can be:

- foreign countries, administrative or territorial bodies of foreign countries;
- international organizations established in accordance with interstate agreements or other agreements or being subjects of international public law;
- legal entities, any other companies, organizations or associations established and operating in accordance with the laws of foreign countries;
- a foreign state, stateless persons and citizens of the Republic of Uzbekistan permanently living abroad.

Special attention should be paid to the work carried out in order to attract investments for the implementation of projects related to the structural change of the country's economy, modernization of industries, and technical and technological renewal. 161 large industrial facilities were launched in our country in a short period of time, which will allow production of additional 1.5 trillion soums next year. At the same time, in 2018, an additional 4 billion 100

million cubic meters of natural gas will be processed due to the commissioning of the large "Kandim" gas processing plant. By the end of 2017, the positive balance of the foreign trade turnover in Uzbekistan reached 854 million dollars. In 2018, 12 free economic zones and 45 industrial zones began to operate in our republic, and in the near future there are practical plans to establish 50 new industrial zones. work is underway. The Republic of Uzbekistan regularly implements mutual cooperation relations with other foreign countries. As a positive result of this, more than 400 deals and agreements were reached with other foreign countries, and as a result, trade and trade in the amount of nearly 60 billion US dollars. investment contracts were signed. This year, a number of important documents on deepening our strategic cooperation with Turkmenistan and Kyrgyzstan were signed, and economic deals worth 2 billion dollars were concluded. In order to make our country attractive for investors who intend to implement large investment projects in Uzbekistan, the necessary work is being done to improve the tax system. When analyzed, the main volume of direct foreign investments corresponds mainly to the city of Tashkent, Tashkent and Samarkand regions and the Fergana Valley. It is planned to attract foreign investments in the amount of 4.505 billion dollars in 2017 within the framework of 199 investment projects in Uzbekistan. The largest part of foreign investments (\$2.47 billion in 37 projects) is in the fuel and energy sector. Of these, 1.97 billion dollars will be invested in the oil and gas sector at the expense of foreign companies' direct investments within 20 projects. Decree No. PF-4434 of the first President of the Republic of Uzbekistan dated April 10, 2012 provides for the provision of benefits to foreign investors and enterprises with foreign investment in accordance with the law. As part of investment projects whose value exceeds 50 million US dollars and the share of a foreign investor is at least 50 percent, the construction of necessary external engineering and communication networks outside the production area is carried out at the expense of budget funds and other internal financing sources.

Summary

Based on the above, if we think about foreign investments, as the honorable President Sh.M. Mirziyoev has emphasized in his numerous speeches, which country wants to be among the developed countries in a short and fast time? first of all, they should pay attention to investments, i.e. foreign investments. Therefore, in our country, special attention is paid to the work in this field.
