### **Abstract**

This study tends to analyze the theme of political corruption and the decay of society in some of the selected poems of Amiri Baraka and to place this analysis in the context of the theory of power by Michel Foucault. Baraka is a well-known and innovative African-American poet and activist, his poems are generally characterized by the intricate presentation of the prevalent power dynamics in the political context and the decay of the society in order to offer a critical perspective on the state of American society. This study will analyze the poems of Baraka in the light of the main concepts and operations that were explained by Foucault's work. The study ultimately aims to show the mechanisms of power and the resulting social decay in contemporary America.

This study starts out by first establishing the theoretical framework that is going to be used in the analytical framework, this theoretical framework depends basically on Foucault's theory of power, which highlights key concepts, such as power as a pervasive and productive force rather than a repressive one, and the notion of power being dispersed throughout society, exerting influence on all aspects of human life. These theoretical notions will be used in this study as a lens to examine the poems of Baraka. The following step will be to analyze some of Baraka's poems with a particular focus on those aspects and lines that explicitly address political corruption and social decay in the American society. All of the poems that are going to be analyzed in this study share the same premises of criticizing the institutional power dynamics that are prevalent in the designated society, these poems tend to expose the corrupt practices and the resulting decay in various realms such as politics, economics, and culture. The study will also focus on the particular poetic language and the vivid imagery that were used in Baraka's poems in order to detect the consequences of unchecked power and its impact on marginalized communities.

Baraka also tends to offer a critical perspective on the state of affairs that are prevalent in that society. Such an analysis can be important in discovering the causes of the social issues and the consequences that are associated with them and the necessity of enforcing the propersocial change. This study will try to understand the mechanisms behind the political corruption and the ways in which this corruption aid in causing the noted decay of the designated society by accurately analyzing the poems of Baraka by the use of the theory of Foucault about power. The theme of social decay is another important issue that is usually analyzed in the poems of Baraka. This analysis is usually done by trying to expose the consequences of the ill power dynamics and the consequences of these dynamics in causing the erosion of the social fabric inside

As mentioned already, Foucault's theory focuses on power as not just a top-down hierarchical structure imposed by those in authority, but rather as a pervasive force that operates through social institutions and practices. This power is productive in the sense that it shapes and molds individuals and society as a whole (Lynch, 2014, pp. 13-26). It is through this lens that we can examine Baraka's poems. The language itself can be seen as a manifestation of power relations and disciplinary mechanisms. Baraka often employs a confrontational and incendiary style that challenges dominant ideologies and structures. This can be noticed in his use of strong and confrontational imagery, as well as his use of vernacular language and African-American cultural references. By using language in this way, Baraka disrupts established power relations and accentuates the need for transformative change. In his poem "Black Art," he utilizes vivid and intense language so as to assert the power and agency of Black people in reclaiming their identity and challenging oppressive systems. For example, he (1979) writes, "We want a black poem. / And / a / Black World." This evokes a sense of rebellion and defiance, positioning the Black experience as a force that disrupts the existing power subtleties and demands recognition
